Government Code 54950 (The Brown Act) requires that a brief description of each item to be transacted or discussed be posted at least 72 hours prior to a regular meeting. # AB 361 Overview 9/30/2021

On September 16, 2021, AB 361 was adopted on an urgency basis (AB 361, section 9) meaning it has immediate effect. Shortly thereafter, Governor Newsome issued an executive order delaying implementation until October 1. After October 1 and through January 1, 2024 (when the bill sunsets), bodies subject to the Brown Act can continue to meet electronically (without the need to allow the pubic to participate from a physical location) after making specific findings and subject to added requirements.

#### Findings

A body subject to the Brown Act may continue to meet virtually when:

1) it is meeting during a proclaimed state of emergency AND

2) either: state or local officials have imposed or recommended measures to promote social distancing <u>OR</u> the body is meeting to determine or has determined by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

Thereafter, at least every 30 days the body must make the following findings by majority vote:

(A) The legislative body has reconsidered the circumstances of the state of emergency.

(B) Any of the following circumstances exist:

(i) The state of emergency continues to directly impact the ability of the members to meet safely in person.

(ii) State or local officials continue to impose or recommend measures to promote social distancing

#### Additional Requirements

In addition to requirements established under the Governor's Executive Orders, public entities that continue to meet virtually must also:

- Allow real-time public comment; may not require public comments to be submitted in advance.
- Allow people to register (get in line) to give public comment during the entire public comment period for a given item.
- Suspend any action in the event of a service interruption. If there is a disruption (within the agency's control) that prevents broadcast of the meeting or prevents the public from providing comments, the body may not take actions until service is restored or those actions may be challenged.

Here at we've been forced to provide our own armed private security Wednesday - Sunday at a cost of \$1k/week.

Unfortunately the laws allow the homeless to trespass, assault, threaten, steal, vandalize, intimidate, and masterbate in front of patrons and employees.

When we go to US Bank for banking, my management team walks from which has security, and crosses the street at Cookies which has security.

Greetings Dominic. This is respond on my observations/impressions of this contracted patrol.

I'm writing this email to

Firstly, I have not noticed any visual impression around our area/business. That might also be due to the fact that I'm not sure what they look like. In my opinion, they should be wearing something to help visually identify themselves as extra security.

I have not reported anything and it hasnt been clear what I should report to them on. Recently, someone hit my car when it was parked while I was working. If the presence of the extra security was strong, than it should deter violence and crimes. I don't think it has made any difference (at least in our area of downtown Hayward).

In general, there are more transients, homeless people in the area than there ever has been in the last five years. Downtown Area is relatively big to only have two security officers walk around. There's also language barriers which I've mentioned, and communication barriers (many merchants and more importantly, the employees) do not know these numbers. If you walked up to any business in the area and asked an employee for the number to this extra security, I'm sure the vast majority will NOT know it.

I definitely appreciate the action and gesture of adding more security. Have I noticed any difference? To put it simply, No. But my response is that we need MORE, in order to get a better assessment and idea of how needed the security is. Not just in the amount of security, but everyone knowing about them and having their numbers ready. I myself, have printed your email with their numbers by my register for my employees to use but I doubt the other merchants have done that.

# To be completely honest we don't think the security that patrols doesn't discourage any illegal activity from happening.

There has been a lot of vandalism going on; our side doors get tagged almost on a weekly basis now. Most of the vandalism happens during the weekends when the patrols are supposed to happen.

For a few weeks there was a homeless woman living in the bushes right next to our exit doors. There have been many times where a homeless person will get into the dumpster/compactor area and use the water to take showers and use that area as a restroom. There have been several times where we have found human feces by our compactor. We have caught guests coming from the near by bars going to the bushes by our exit doors to urinate.

This past weekend someone was able to turn off our water main.

Car break ins are still an issue. Our overnight janitorial crew has had their car broken into several times and even stolen once. About two weeks ago I was getting picked up from work by my fiancé and someone tried stealing his car while he went to throw something away. Our GM, , had her car windows smashed just a few months ago.

The only time we see security is when they come in to our building without masks to use our restrooms.

We need better security and for them to patrol later at night.
